WHEREAS, Article XIV, Section 2(3) of 1987 Republic of the Philippine Constitution, provides that, "Establish and maintain a system of scholarship grants, student loan programs, subsidies, and other incentives which shall be available to deserving students in both public and private schools, especially to the underprivileged.";

WHEREAS, Article 99(5) (ix) of Republic Act No. 7160, otherwise known as the Local Government Code (LGC) of 1991, provides that, "Establish a scholarship fund for poor but deserving students in schools located within its jurisdiction or for students residing within the city;"

WHEREAS, on July 17, 2017 the 8th Sangguniang Panlungsod of Muntinlupa enacted Ordinance No. 17-107, entitled, "An ordinance providing for an expanded Muntinlupa Scholarship and Educational Assistance Program and other Incentives to Students, providing funds therefor and for other purposes.";

WHEREAS, on October 25, 2021, the 9th Sangguniang Panlungsod of Muntinlupa adopted Resolution No. 2021-545, "A resolution authorizing the City Mayor Atty. Jaime R. Fresnedi to enter and sign the Memorandum of Agreement (MOA) Between the Pamantasan ng Lungsod ng Muntinlupa and Ospital ng Muntinlupa Medical Center for the opening of a Doctor of Medicine Program."

WHEREAS, the Ospital ng Muntinlupa Medical Center (OSMUNC) proposed a scholarship program for Muntinlupa residents enrolled at the PLMUN-OsMun College of Medicine;

WHEREAS, upon careful review of the existing provisions of the Scholarship Ordinance, Muntinlupa Scholarship Division, the sole implementing office of the program, proposed amendments to scholarship grants given to Law and Medicine Students;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 10th Sangguniang Panglungsod of Muntinlupa in session assembled that:

SECTION 1. *Short Title* – This ordinance shall be known as, "An ordinance amending Section 2(18) of Ordinance No. 2021-107".

SECTION 2. *Amendments*- Section 2(18) of Ordinance No. 17-107, reads as follow:

18. *Law and Medicine Program* – granted to 40 students enrolled in law and medical schools in Luzon, with a maximum financial assistance of **Thirty Thousand Pesos (Php30,000.00)** per year for *Medical Students* and a maximum of **Twenty Thousand Pesos (Php20,000.00)** per year for *Law Students*, provided he or she complies with requirements set by the Muntinlupa Scholarship Program.

AND NOW SHALL BE READ AND AMENDED AS FOLLOWS:

18. *Law and Medicine Program* – Granted to 40 students enrolled in law and medical school in Luzon. *For the Medical Degree* program, a student shall receive **Thirty Thousand Pesos (P30,000)** per semester. On top of the semestral assistance, the student shall receive additional grant amounting to **Twenty Thousand Pesos (P20,000.00)** if he or she will qualify to be accepted to the PLMUN-OsMun College of Medicine. For the *Law Degree* a student shall receive **Twenty Thousand Pesos (P20,000.00)** per semester. *Provided that*, he or she complies with requirements set by the *Muntinlupa Scholarship Division (MSD)*.

SECTION 3. *Seperability Clause* - If any provision of this ordinance is held invalid or unconstitutional, any other provision not so affected shall continue to be valid and effective.

SECTION 4. *Repealing Clause* - All ordinances, resolutions, and orders contrary or inconsistent with the provisions of this Ordinance are hereby repealed or amended accordingly.

SECTION 5. *Effectivity Clause* - This Ordinance shall take effect upon its approval.

ENACTED, by the 10th Sangguniang Panlungsod of Muntinlupa this 3rd day of October 2022, on its 14th Regular Session.

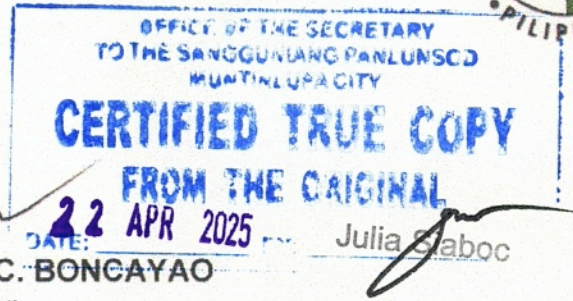
