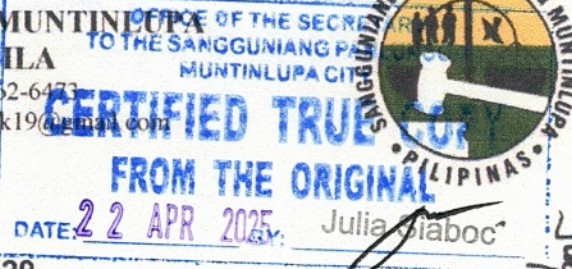

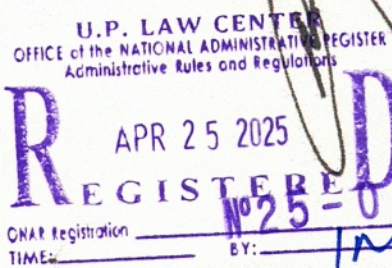

AN ORDINANCE PRESCRIBING AN UPDATED REGULATORY FEES FOR TESTS BEING DONE IN THE LABORATORIES/CLINICAL FACILITIES UNDER THE SUPERVISION OF THE CITY HEALTH OFFICE

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code (LGC) of 1991, empowers the Sanggunian to: "Generate and maximize the use of resources and revenues for the development plans, program objectives and priorities of the city". Thus, "Subject to the provisions of the LGC and applicable laws and upon the majority vote of all the members of the Sangguniang Panlungsod, enact ordinances levying taxes, fees and charges, prescribing the rates thereof for general and specific purposes, and granting tax exemptions, incentives or reliefs";

WHEREAS, Administrative Order No. 2021-DO37 of the Department of Health underscores the importance of clinical laboratory services, both private and public, in the diagnosis, treatment, prevention and control of disease. Thus, it is imperative that the laboratories generate accurate, precise and reliable laboratory test results in a timely manner to aid the physicians in assuring the quality of patient care;

WHEREAS, the City Health Office manages a clinical laboratory within the city limits and has been servicing the general public's diagnostic needs in affordable fees prescribed under Ordinances 18-176 and 09-086;

WHEREAS, primarily to be at par with the standards of the said industry, the fees being imposed on clinical tests need to be upgraded as the price of reagents being used have increased;

NOW THEREFORE, BE IT ORDAINED, AND HEREBY ORDAINED, by the 10th Sangguniang Panlungsod of Muntinlupa, in Session assembled that:

SECTION 1. Title - This ordinance shall be known as "Upgraded Laboratories/Clinical Fees.



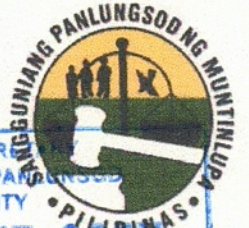

SECTION 2. Upgraded Laboratory/Clinical Tests Fees. There shall be imposed an upgraded Laboratory/Clinical Test fees as follows:

Laboratory Services	Current Fees (per Ordinance No. 18-176)	Updated Fees

2. Fecalysis	50.00	60.00
3. Hemoglobin and Hemotocrit	50.00	60.00
4. Complete Blood Count	100.00	120.00
5. Complete Blood Count with Platelet Count	150.00	180.00
6. Blood Typing with RH	150.00	180.00
7. HBsAG Screening Test	180.00	200.00
8. Pregnancy Test	120.00	140.00
9. Gram Stain(c/o RHC)	100.00	120.00
10. Dengue Rapid Test/NS1	700.00	800.00
11. Hba1c	450.00	500.00
12. Pap Smear	Free of Charge	150.00
13. Antigen	(NEW)	250.00

SECTION 3. Repealing Clause – All ordinances and local executive orders or parts thereof which are inconsistent with any part of the provisions of this ordinance is hereby repealed or amended accordingly.

SECTION 4. Separability Clause – If, for any reason or reasons, any part or provisions of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 5. Effectivity Clause – this ordinance shall take effect upon its approval.

ENACTED, by the 10th Sangguniang Panlungsod of Muntinlupa, this 12th day of December 2022, on its 23rd Regular Session.

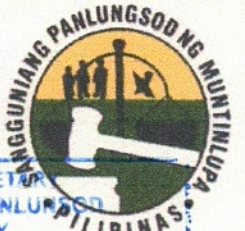
