AN ORDINANCE PROVIDING FOR THE REVISED FEES FOR RADIOLOGY PROCEDURE/S IN HEALTH FACILITIES UNDER THE SUPERVISION OF THE CITY HEALTH OFFICE AMENDING FOR THIS PURPOSE SECTION 1 (C) OF ORDINANCE NO. 09-086 OTHERWISE KNOWN AS AN ORDINANCE REGULATING THE OPERATION OF HEALTH SERVICES RENDERED IN DIFFERENT LOCAL GOVERNMENT HEALTH FACILITIES WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF MUNTINLUPA

WHEREAS, Section 458 of the Local Government Code of 1991, empowers the Sangguniang Panlungsod, upon the majority vote of all the members, to enact ordinances levying taxes, fees and charges, prescribing the rates thereof for general and specific purposes, and granting tax exemptions, incentives or reliefs;

WHEREAS, the Sangguniang Panlungsod enacted various ordinances prescribing the rates for the fees to be collected in laboratory tests, radiology services such as Ordinance No. 09-086, entitled, *An Ordinance Regulating The Operation Of Health Services Rendered In The Different Local Government Health Facilities Within The Territorial Jurisdiction Of The City Of Muntinlupa Such As Laboratory Tests, Operation Of Lying-In Centers And Radiology Services, And Prescribing Fees Therefore Pursuant To The Local Government Code And Other Pertinent Laws; Ordinance 18-176*, where the fees to be collected for laboratory services were increased and the latest; Ordinance 2022-029, providing for updated regulatory fees for laboratory services, in effect amending Ordinance 18-176;

WHEREAS, to conform to the rising cost of materials and maintenance of radiology equipment, the need to update the fees for radiology procedure is necessary;

NOW THEREFORE BE IT ENACTED, by the 10th Sangguniang Panlungsod of Muntinlupa in session assembled that:

SECTION 3. Separability Clause – If, for any reason or reasons, any part or provisions of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 4. Repealing Clause. All previous ordinances inconsistent with this ordinance shall be deemed repealed or modified accordingly.

SECTION 5. Effectivity Clause – This ordinance shall take effect after its completion of its publication in a newspapers of general circulation.

SECTION 6. Publication. This Ordinance shall be published pursuant to the requirements of the Local Government Code and shall be posted by the Public Information Office (PIO) in the Official Website of the City Government of Muntinlupa and in all available social media platforms.
