WHEREAS, Section 15 of Article II of the 1987 Constitution, declares that, "The State shall protect and promote the right to health of the people and instill health consciousness among them";

WHEREAS, Section 13 of Article II of the 1987 Constitution mentions that, "The State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being. It shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs";

WHEREAS, Section 3 of Republic Act 9163 defines National Service Training Program (NSTP) as, "a program aimed at enhancing civic consciousness and defense preparedness in the youth by developing the ethics of service and patriotism while undergoing training in any of its three (3) program components. Its various components are specially designed to enhance the youth's active contribution to the general welfare";

WHEREAS, Section 14 of Republic Act 10121 mentions that, "The DepED, the CHED, the Technical Education and Skills Development Authority (TESDA), in coordination with the OCD, the National Youth Commission (NYC), the DOST, the DENR, the DILG-BFP, the DOH, the DSWD and other relevant agencies, shall integrate disaster risk reduction and management education in the school curricula of secondary and tertiary level of education, including the National Service Training Program (NSTP), whether private or public, including formal and non-formal, technical-vocational, indigenous learning, and out-of-school youth courses and programs";

WHEREAS, Section 21 of Republic Act 10121 provides that, "**Xxx. Not less than five percent (5%) of the estimated revenue from regular sources shall be set aside as the LDRRMF to support disaster risk management activities such as, but not limited to, pre-disaster preparedness programs including training, purchasing life-saving rescue equipment, supplies and medicines, for post-disaster activities, and for the payment of premiums on calamity insurance. Xxx.**";

WHEREAS, Section 2 of Republic Act 10871, declares that, "**Xxx, the State shall ensure that able-bodied citizens are equipped with the necessary knowledge and basic skills to respond to certain health emergencies**";

WHEREAS, Disaster Preparedness is part of the "7K Agenda" under "Karunungan", and "Kapayapaan/Kaayusan" of the Administration of Mayor Rozzano Rufino B. Biazon;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 10th Sangguniang Panlungsod of Muntinlupa, in the session assembled that:

SECTION 1. Short Title. — This Ordinance shall be known as "*Muntinlupa City School-Based Disaster Preparedness Training Ordinance.*"

SECTION 2. Definition of Terms. – For purposes of this Ordinance, the following shall mean:

- (a) **Disaster Preparedness** - refers to "the knowledge and capacities developed by governments, professional response and recovery organizations, communities and individuals to effectively anticipate, respond to, and recover from, the Impacts of likely, imminent or current hazard events or conditions. Preparedness action is carried out within the context of disaster risk reduction and management and aims to build the capacities needed to efficiently manage all types of emergencies and achieve orderly transitions from response to sustained recovery. Preparedness is based on a sound analysis of disaster risk and good linkages with early warning systems, and includes such activities as contingency planning, stockpiling of equipment and supplies, the development of arrangements for coordination, evacuation and public information, and associated training and field exercises. These must be supported by formal institutional, legal and budgetary capacities."
- (b) **Basic Life Support** - refers to "Basic Life Support (BLS) refers to a set of emergency procedures that consists of recognizing respiratory or cardiac arrest and proper application of Cardiopulmonary Resuscitation (CPR) with or without Automated External Defibrillation (AED), Foreign Body Airway Obstruction Management (FBAOM), and Rescue Breathing (RB) to maintain life until a victim recovers or advanced life support is available."

SECTION 3. Scope. — The Education Sector, all levels of public and private schools, in all Barangays within the jurisdiction of Muntinlupa shall participate in this program.

SECTION 4. Basic Life Support for Basic Education Students. — It shall be the duty of all public and private basic education schools operating within the City of Muntinlupa to provide their students with basic life support training through the use of psychomotor training in an age-appropriate manner. The instruction shall include programs which have been developed by the Philippine Heart Association (PHA) or Philippine National Red Cross (PNRC) using nationally-recognized, evidence-based guidelines for emergency cardiovascular care, and psychomotor training, to support the instruction. As far as practicable, basic education schools shall incorporate basic life support training as part of the schools' comprehensive health and physical education curriculum.

SECTION 5. Training for Higher Education Students. — Higher Education Students shall be trained in Disaster Preparedness which includes but not limited to Basic Life Support, First Aid, and Triage. The training program may be integrated in the National Service Training Program (NSTP), Physical Education (PE), or other relevant courses in the school curricula.

SECTION 6. Registration of National Service Reserve Corps (NSRC) — Graduates of non-ROTC Components of NSTP shall compose the NSRC. Members of this Corps may be tapped by the State for literacy and civic welfare activities through the joint effort of the DND, CHED and TESDA. The roster of NSRC graduates shall be maintained by the Muntinlupa City Department of Disaster Resilience and Management (DDRM).

SECTION 7. Training of Trainers. The City Government of Muntinlupa shall provide training to teaching and non-teaching personnel, parents, guardians, and other stakeholders on disaster preparedness who may be willing to impart/ download the assimilated trainings to other individuals;

SECTION 8. Certification for Training. — All successful student-trainees shall be certified to have undergone the training required by a competent authority.

SECTION 9. Training Providers. — The school head or administrator shall coordinate with the City Health Office (CHO), or the Muntinlupa City Department of Disaster Resilience and Management (DDRM) for assistance in providing competent instructors for the school's disaster preparedness, and basic life support training program.

SECTION 10. Exceptions. — Students suffering from any physical or mental disability which may render them unable to perform a basic life support procedure are exempted from going through the basic life support training program.

SECTION 11. Mandatory Drill. To prepare schools and its complement students/pupils in events of disaster/s, a mandatory emergency drill of at least once (1) a year shall be implemented.

SECTION 12. Appropriations. — The budget for training may be taken from the Local Disaster Risk Reduction and Management Fund (LDRRMF), and other sources as may be allowed by law.

SECTION 13. Implementing Rules and Regulations — The Youth Affairs and Sports Development Office (YASDO) together with the Local Youth Development Council (LYDC), City Health Office (CHO), Muntinlupa City Department of Disaster Resilience and Management (DDRM), the Schools Division Office – Muntinlupa City (SDO Muntinlupa), and other concerned offices of government that may be determined by the YASDO, shall formulate the implementing rules and regulations of this Ordinance within ninety (90) days after its approval.

SECTION 14. Repealing Clause. — All Ordinances, issuances, rules and regulations inconsistent with the provisions of this Ordinance are hereby repealed, amended, rescinded and/or modified accordingly.

SECTION 15. Separability Clause. — If any provision of this Ordinance shall be held unconstitutional or invalid, the other provisions not otherwise affected shall remain in full force and effect.

SECTION 16. Effectivity Clause. — This Ordinance shall take effect upon approval of the City Mayor.
