AN ORDINANCE AMENDING SECTION 17 OF ORDINANCE 2022-035 OTHERWISE KNOWN AS THE WOMB TO WORK PROGRAM (WWP) TO AUTHORIZE THE GENDER AND DEVELOPMENT (GAD) OFFICE TO ALLOCATE/ UTILIZE ITS APPROVED BUDGET FOR THE IMPLEMENTATION OF THE WWP

WHEREAS, on December 27, 2022, the 10<sup>th</sup> Sangguniang Panlungsod enacted Ordinance No. 2022-035, otherwise known as "Womb to Work Program"(WWP);

WHEREAS, the 2023 Executive Budget was approved on December 14, 2022, hence, the GAD Office, the intended primary implementor of the WWP of the City Government of Muntinlupa, was not able to include the WWP in its 2023 programs allocation;

WHEREAS, for the year 2024, the GAD Office was able to include in its Annual Investment Program (AIP) the allocation of funds for the implementation of Womb to Work Program (WWP);

NOW THEREFORE, BE IT ENACTED, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, in session assembled that:

SECTION 1. **Short Title** – This ordinance shall be known as the amendment of Section 17 of Ordinance No. 2022-035;

**SECTION 2. Amendment.** Section 17 of Ordinance No. 2022-035 provides:

Section 17 of Ordinance No. 2022-035, Budget and Appropriation -  
*"The budget for the implementation of the Womb to Work Program shall come from the General Fund and/or budget of the Implementing Offices, as may be appropriate. Thereafter, the implementing offices and other relevant offices participating in this program shall appropriate a sufficient budget every year for the continuous operation of the Womb to Work Program.*

**SHALL NOW BE AMENDED TO READ AS FOLLOWS:**

Section 17. Budget and Appropriation - *the Budget for the implementation of Womb to Work Program shall be taken from the allocated/approved budget of the Gender and Development (GAD) Office. The GAD Office is hereto directed to include in its Annual Investment Program sufficient budget every year for the continuous operation of the Womb to Work Program.*

**SECTION 3. Guidelines** – The guidelines for this Ordinance shall prepare by the Gender and Development Office for its proper implementation.

**SECTION 4. Appropriation** – The amount for this program shall be appropriated from the **General Fund** under **Gender and Development Office (GAD)** and/or budget of the **Implementing Offices**, as may be appropriate.

**SECTION 4. Separability Clause** - If for any reason, a part of this Ordinance is declared illegal or invalid, other parts or provisions hereof which are not affected thereby shall remain valid and in full force and effect.

**SECTION 5. Repealing Clause** - Provisions on the City Ordinance No 2022-035 and its amendments, insofar as inconsistent herewith and all other existing ordinances, executive orders and administrative regulations or part of parts thereof which are inconsistent with any provision of this Ordinance are hereby repealed or modified accordingly.

**SECTION 9. Effectivity** – The ordinance shall take effect upon approval.

**ENACTED**, by the **10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa** this **22<sup>ND</sup>** day of **August 2023**, on its **59<sup>th</sup> Regular Session**.
