SUBJECT : UNAUTHORIZED USE OF ARTA'S NAME AND OFFICIAL LOGO

DATE : 8 April 2025

It has come to the attention of the Anti-Red Tape Authority (ARTA) that the organization, **KATILINGBAN SANG NAG-HILIUSA (KASANAG), INC.** and/or **TASK FORCE KASANAG (TFK)**, has been using the logo and name of ARTA in their correspondence with local government units (LGUs) without express authority or permission from ARTA.

This advisory is being issued to notify all government agencies and the transacting public that **ARTA is NOT affiliated or associated with KASANAG and/or TFK.** There is no valid and existing agreement with the said organization. ARTA has not authorized the use of its name and official logo in any letterhead or official correspondence of KASANAG and/or TFK, nor is there any authority given to it or its officers/members to represent or speak on behalf of the agency. The actions of KASANAG and/or TFK are of their own accord and do not carry with them the endorsement or sanction of ARTA.

In this regard, private individuals or organizations are hereby warned that knowingly and falsely representing themselves to be an officer, agent, or representative of ARTA, or who, under the pretense of holding an official position at ARTA, shall perform any act pertaining to any person in authority or public officer of ARTA, without being lawfully entitled to do so, is a crime punishable under the Revised Penal Code.

The public is hereby urged to report any unauthorized use of its name and official logo to ARTA Legal through legal@arta.gov.ph.
